Applications are invited from suitable candidates for engagement of 2 (two) Peons [UR-1 & SC-1] on contractual basis with consolidated monthly remuneration at the rates prescribed in the annexure appended to Odisha Group-C and Group-D Posts (Contractual Appointment) Amendment Rules, 2017, as applicable to their number of completed years of service subject to satisfactory performance. Their remuneration shall be enhanced as per slabs prescribed under the Annexure appended to these Rules on completion of each year of service. The appointees shall not be entitled to any service benefits as admissible to regular State Government servants and the appointments shall be made in terms of Group-C and Group-D post (Contractual Appointment) Rules, 2013 as per G.A. Department Notification No.GAD-SC-Rules-0009-2013.32010/Gen, dtd.12.11.2013 read with Odisha Group-C and Group-D Posts (Contractual Appointment) Amendment Rules, 2017.

The vacancy position shown may be increased if any vacancy is caused during the process of Selection.

The qualification and other eligibility for the aforesaid Contractual appointment are as follows:

1. The candidates should have passed M.E. Examination in the minimum.
2. Age Limit: 18 - 32 years of age (as on 1.1.2021). Upper age limit is relaxable in respect of candidates belonging to reserved categories and women candidates, as per Rules.
3. They should know cycling well.
4. They should mention the Employment Exchange Registration number in the application.
5. The selection will be made purely on the basis of merit.

The candidates are instructed to attach self attested copies of educational certificates, Photographs (two Passport size) and caste certificate along with their application Form.
