Applications are invited from the eligible UR/SEBC/SC/ST/PWD/Ex-Serviceman candidates for recruitment of 01(one) post of Peon on regular basis in the scale of pay of Rs.16,600-52,400/- in Level-1 of the Pay Matrix under ORSP, Rules 2017 with usual D.A. and other allowances as admissible by the Government of Odisha from time to time.

The vacancy position shown may be increased, if any vacancy is caused during the process of Selection.

1. The candidates should have passed M.E. Examination in the minimum.
