Walk-in-Interview for the post of Research Associates is invited from the eligible candidates for engagement of 7 (seven) Research Associates in the OFFICE OF THE ADVOCATE GENERAL, ODISHA on contractual basis keeping exigency of workload in the office in mind and for smooth conduct of Court Cases in The High Court of Orissa and Supreme Court of India.

The contractual engagement shall be for a term of one year, which may be extended further one additional year. Maximum years of engagement for each candidate shall not exceed two years. 1. Eligibility Criteria:

(i) Age: A candidate shall not be less than 21 years and not more than 35 years of age, as on the date of advertisement.

(ii) Educational qualification:

- a. Any Law Graduate/ Post Graduate from a University/ College recognized by the Bar Council of India having minimum two years' experience in any legal firm/office shall be eligible to apply.
- b. Candidates having familiarity with computer will get preference in the matter selection.
- c. The candidature of a candidate who is practicing Lawyer must be recommended by a Advocate who is a life member of the High Court Bar Association, Orissa.

2. Honorarium/Stipend of Law Researcher/Research Associate:

- (i) Each Research Associate will be paid a consolidated amount of Rs. 35,000/- per month as Honorarium/ stipend for his/ her engagement or such higher amount as may be prescribed by the State Government from time to time in this regard.
- (ii) The Research Associate shall not be entitled to any other allowance and/or remuneration, and will not be treated as a permanent or otherwise employee of Office of the Advocate General, Odisha or the State Government.

3. Enclosures to be submitted with the application form:

- (i) Matriculation Certificate in proof of date of Birth.
- (ii)Mark sheet (of all the semesters/years) of Law Graduation and Post Graduation (if applicable).
- (iii) Provisional/Original degree Certificate of Law Graduation and Post Graduation (if applicable).
- (iv) Computer certificate, if any.

4. Bar to Practice:

- (i) The Research Associate shall not be entitled to practice as a lawyer or to take up any employment, engagement of whatsoever nature on full time or on part time basis to which effect an undertaking shall be furnished by the selected candidate.
- (ii) The Research Associate attached to a particular Law Officer shall not be entitled to appear before any Court of Law for a period of six month from the date of termination of the engagement.
- (iii) He/she shall not be entitled to appear in any case where Govt. Orissa is a party, if he/she had worked on that case.

5. Selection Procedure: The selection shall be based on merit and interview.
